




Sheltered PIT Counts 2023 - 2024




Unsheltered PIT Counts 2023 - 2024



Not Sheltered or Unsheltered PIT Counts 2023 - 2024




Town Level Unsheltered PIT Counts 2023 - 2024








2024 PIT Count- Age




2024 PIT Count Race & Ethnicity Disparities




2024 PIT Count – "Are you aware of local shelters?"




2024 PIT Count- "Would you be open to staying in a local shelter if there were beds available?"

Additional Suggestions Through PIT Surveys – Unsheltered (Berkshire County)

- "We need vouchers, affordable housing"

Additional Suggestions Through PIT Surveys – Unsheltered (Franklin County)

Housing & Shelter Program Types

- Emergency Shelter (ES) A project that offers temporary shelter (lodging) for people experiencing homelessness in general or for specific populations of people experiencing homelessness.
- Other Permanent Housing (OPH) A project that offers permanent housing for people experiencing homelessness but does not make supportive services available as part of the project.
- Permanent Supportive Housing (PSH)- is permanent housing with indefinite leasing or rental assistance paired with supportive services to assist homeless persons with a disability or families with an adult or child member with a disability achieve housing stability.
- Rapid Re-Housing (RRH)- A permanent housing project that provides housing relocation and stabilization services and shortand/or medium-term rental assistance as necessary to help a homeless individual or family move as quickly as possible into permanent housing and achieve stability in that housing.
- Safe Haven (SH)- A project that offers supportive housing that serves hard-to-reach people experiencing homelessness with severe mental illness who have been unsheltered and have been unwilling or unable to participate in supportive services; provides 24-hour residence for eligible persons for an unspecified period; has an overnight capacity limited to 25 or fewer persons; and provides low-demand services and referrals for the residents.
- **Transitional Housing (TH)** provides temporary housing for the certain segments of the homeless population, including working homeless making insufficient wages or homeless individuals with mental or physical disabilities who have trouble affording long-term housing, and is set up to transition their residents into permanent, affordable housing within a reasonable amount of time (usually 24 months).
